Please note that fees are not refundable nor may modules be transferred to another individual.

- From 1st September 2010 fees per module, including tutorial support, assignment, workshop and examination are £1,310.

- Alternatively you can buy the programme of eight modules at an inclusive fee, payable in two equal instalments, one at the start of the programme and the second after the first year of study.
- This inclusive price is currently £10,480.
- The additional supervision and examination fee for an MSc is £1,310 payable when the project starts.
- Expenses incurred by the University Supervisor for site visits (usually a minimum of two) are also charged to the student.
- An additional fee of £2,100 will be applied if you use the course for QP Training.
